

Perpetrators who involved in Meiktila received sentences

Meiktila, 10 July— Actions against perpetrators who involved in the violence occurred in Meiktila on 20 March 2013 have been taking place. On 10 July 2013, the district and township courts have decided sentences for those who found guilty.

Offenders, namely Saw Hla Tun (aka) Kyar Gyi was sentenced for two years' imprisonment with hard labour under Section 379, Hein Min Zar (aka) Watote was sentenced for seven years' imprisonment with hard labour under Section 326 and for two years' imprisonment with hard labour under Section 379, Kyaw Swar (aka) Mohamad Ali was sentenced for seven years' imprisonment with hard labour under Section 326, one year imprisonment with hard labour under Section 427 and ten years' imprisonment with hard labour under Section 302(2), Ko Oo (aka) Maung Oo was sentenced for two years' imprisonment with hard labour under Section 379, Aung San Yu (aka) Win Hlaing was sentenced for two years' imprisonment with hard labour under Section 379, Lin Lin Aung was sentenced for one year imprisonment with hard labour under Section 379, Shontke (aka) Win Myint Thein was sentenced for two years' imprisonment with hard labour under Section 379, Myint Soe was sentenced for two years' imprisonment with hard labour under Section 379, Maung Naing (aka) Kyaw Naing was sentenced for one year imprisonment with hard labour under Section 427 and for three years' imprisonment with hard labour for Section 436/114, Aung Tun was sentenced for one year imprisonment with hard labour under Section 427, for five years' imprisonment with hard labour under Section 436, Kyaw Htay (aka) Kyaw Sein Win was sentenced for five years' imprisonment with hard labour under Section 326 and for ten years' imprisonment with hard labour under Section 302(2), Sin Pauk (aka) Pyae Phyo Zin was sentenced for ten years' imprisonment with hard labour under Section 302(2), Zaw Lin was sentenced for ten years' imprisonment with hard labour under Section 302(2) and for two years' imprisonment with hard labour under Section 144, Aung Zaw Htay (aka) Good Fighter was sentenced for five years' imprisonment with hard labour under Section 326 and for two years' imprisonment with hard labour under Section 144, Pyte Htwe was sentenced for three years' imprisonment with hard labour under Section 326/144.

Similarly, Win Zaw Oo, Aung Tun, Win Tun, Kalar Gyi, Kyaw Oo, Nwe Nwe Win, Kyaw Naing (aka) Maung Naing were sentenced for two years' imprisonment with hard labour under Section 427. Nwe Nwe Win was sentenced two years' imprisonment under Section 505.
